Masterclass

Presentation and rules

The Lerici Music Festival - Associazione Suoni dal Golfo organizes a masterclass within Saxophone Week, a three-day course from July 31st to August 2nd 2021 with international professors and concert performers such as Gaetano Di Bacco, Asya Fateyeva, Philippe Geiss, Dariusz Samól, Kennet Tse. The main feature of the course will be the carrying out of an individual lesson of 45 minutes with each of the teachers, for a total of five lessons for each student.

Active participants will be able to attend for free Philippe Geiss' lecture on August 3rd - "CONFERENCE ON SOUND EXPLORATION AND SPACE INSPIRATION" and the meetings organized with construction and maintenance companies of instruments and accessories; moreover, the actual participants will have a 50% discount on two tickets for the concerts of August 4th and 5th at the Lerici Music Festival.

The course is aimed at young musicians who want to improve their musical skills by taking advantage of a highly specialized training opportunity given by well-known teachers and concert performers.

The repertoire of the course is free.

The masterclass will take place with a minimum of n. 8 students and it will have a maximum of 20 active students.

An admission test is required to attend the course, which consists in sending a video of no more than 10 minutes (without editing) of a piece chosen by the candidate.

By June 25th, a commission, which includes some of the teachers of the course, will select the candidates and send an email to all participants with the response.

Candidates admitted as active students must proceed with the bank transfer of the sum established as the attendance fee and send the copy of the receipt within 5 days.

At the end of the masterclass, each active student will get an attending certificate.

Further regulations

Registration for courses implies having read and accepted the entire regulation.

The costs of meals, accommodation and travel are the responsibility of the participants.

The organization assumes no responsibility for theft, damage and accidents to instruments / things and people during the entire period of the course.

Students are required to comply with this regulation and the subsequent provisions of the Covid-19 protocol which will be illustrated to the participants on site. In the event of serious reasons, such as repeated non-compliance with the regulations, inadequate behavior, expulsion from the course is expected.

In the event of expulsion, the attendance fees will not be refunded and the student will unconditionally accept the final judgment of the teachers and the organization.

In case of cancellation of the masterclass and of the events due to force majeure also related to the sanitary situation caused by Covid-19, the attendance fees will be fully refunded.

For minors, enrollment in courses must be carried out by one of the parents who exercises parental responsibility.

Lessons that for reasons not dependent on the organization the active students will not take can neither be recovered nor reimbursed.

Any withdrawals from courses after registering must be communicated in writing strictly 15 days before the start date of the course.

The attendance fee will be fully refunded only if the course is canceled due to failure to reach the number of subscribers.

The organization reserves to make changes to the schedule if unforeseen events arise.

For any legal dispute, the place of jurisdiction is the La Spezia's tribunal.
